**THE PROVINCE OF MANITOBA REPRESENTED BY THE MINISTER OF  
HIGHWAYS AND TRANSPORTATION: The "Licencee"**

for the construction and operation of the Development being the upgrading and relocation of 1.2 km of Provincial Road #262 at the intersection of Provincial Trunk Highway #10 in the Rural Municipality of Odanah and subject to the following specifications, limits, terms and conditions

**SPECIFICATIONS.LIMITS.TERMS AND CONDITIONS**

- 1) The Licencee shall construct the Development in accordance with the alignment described as *Alternative "A"* in the Environment Act Proposal, dated February 11, 1991.
- 2) The Licencee shall construct the "artificial wetland" in accordance with the plan *Proposed Wetland Construction Near P.T.H.#10 / P.R.#262, May 1992* filed as additional information to the Environment Act Proposal, dated February 11, 1991.
- 3) The Licencee shall not use any pesticides on the Development to control vegetation.

**REVOCAION**

If in the opinion of the Director the Licencee has not complied or is not complying with the specifications, limits, terms or conditions set out herein, the Director may revoke, temporarily or permanently, this Licence.


