THIS LICENCE IS ISSUED TO:

THE LOCAL GOVERNMENT DISTRICT OF FISHER: The "Licencee"

for the construction of the Development being one mile of road located in the Local Government District of Fisher east of 20-24-1WPM subject to the following specifications, terms and conditions:

1. The Licencee shall construct the Development in accordance with the Environment Act Proposal filed on June 25, 1993.
2. The Licencee shall schedule construction of the Dumoulin Drain crossing after June 15 of the construction year.
3. The Licencee shall, during construction of the Dumoulin Drain crossing, adhere to the Manitoba Department of Natural Resources' guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.
4. The Licencee shall, during construction, ensure that any fuel storage areas established for the construction of the Development are located a minimum distance of 100 meters away from waterbodies, and ensure the storage areas comply with the requirements of *Manitoba Regulation 97/88R - Storage and Handling of Gasoline and Associated Products Regulation*.
5. The Licencee shall, during and upon completion of construction of the Development, collect and dispose of all waste petroleum products generated by the construction activities in accordance with all applicable regulatory requirements.
6. The Licencee shall, during the full term of the construction of the Development, cleanup and deposit all debris from the construction site at a Waste Disposal Ground operating under the authority of a permit issued pursuant to *Manitoba Regulation 150/91R - Waste Disposal Grounds Regulation*.
7. The Licencee shall, at the completion of the construction of the Development, landscape and vegetate all areas disturbed during the construction with native and/or introduced plant species. Rip-rap or similar erosion control materials shall be used to prevent erosion in areas where vegetative cover cannot be established.
