In light of the recent acquisition of the ag retail locations from Viterra Inc., please change the legal name of the Environment Act License 1618 RR for Arborg, MB to Crop Production Services (Canada) Inc.

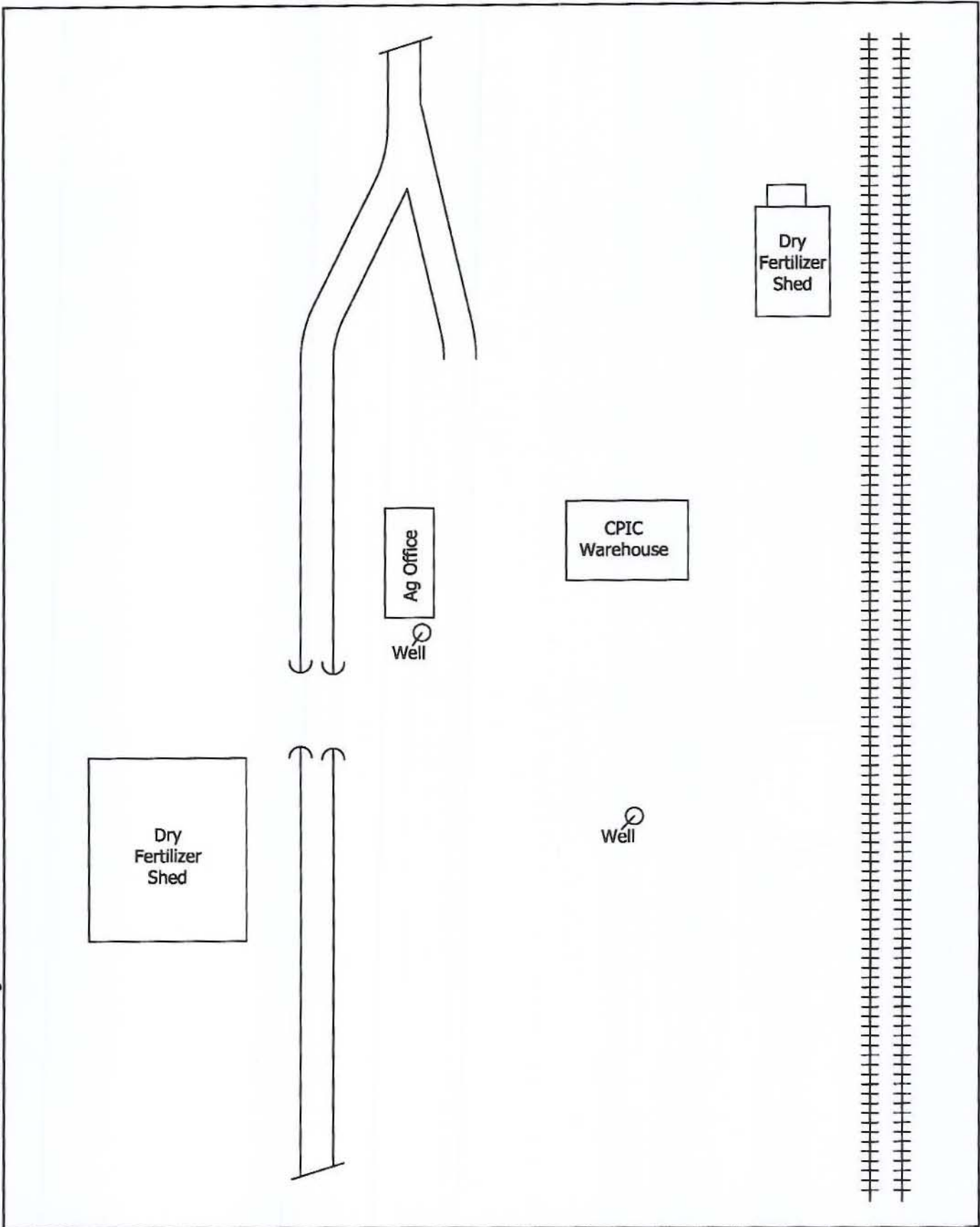
While License 1618 RR shows that the facility was licensed to operate a crop protection products warehouse and distribution facilities, legacy companies added a granular fertilizer plant which has been in operation for 30+ years. At this time, we would like to notify you that Crop Production Services (Canada) Inc. plans to continue to sell granular fertilizer from this location. Total granular fertilizer capacity for this location is 2,600 tonnes which is stored in two dry fertilizer sheds. Concrete loads pads are in place for both dry fertilizer sheds.
