**Re: Notice of Alteration – Environment Act Licence No. 3096 – Addition of Waste Transfer Station to Development Operations**

Thank you for your July 22, 2020 Notice of Alteration submission to Environment Act Licence No. 3096. The alteration request consists of developing a waste transfer station within the existing Lalor site located at NW 9-68-18 WPM, to include collection and management of combustibles, recyclables, and domestic waste streams. The request is in response to changes to the definition of waste management facilities under the Waste Management Facilities Regulation.

Upon review of your alteration request, I have concluded that the environmental effects of the proposed alteration will be insignificant and, therefore, you are hereby authorized to develop a transfer station at the Lalor site subject to the following terms and conditions:

**General Terms and Operating Conditions**

1. The Licencee shall maintain and operate the Lalor Waste Transfer Station (the Facility) in accordance with the most current version of the Waste Management Facilities Regulation and this authorization.
2. The Licencee shall develop an Operations Manual detailing the operation and maintenance for this Facility in accordance with the Waste Management Facilities Regulation. This manual should include but not be limited to a detailed list of waste and recyclable materials accepted, emergency and safety procedures, location where materials not accepted are diverted to and maintenance and closure activities. The Licencee shall provide the Manual to an Environment Officer upon request.

3. The Licencee shall maintain a copy of the Operations Manual developed pursuant to Clause 2 of this approval and a copy of this authorization at the Facility or where the Facility is managed.
4. The Licencee shall obtain approval in writing from the Director for any proposed alterations to the Facility before proceeding with the alteration.

### **Site Access and Control**

5. The Licencee shall restrict public access to the Facility with a locked gate, barrier or other system approved in writing by an Environment Officer.

### **Materials Acceptance and Handling**

6. The Licencee shall segregate materials collected for recycling or reuse, and shall temporarily stockpile these materials in clearly signed designated areas. These areas must be maintained to control weeds, vectors and quality of the materials.
7. The Licencee shall remove the materials identified in Clause 6 of this approval regularly or upon the request of an Environment Officer, within the timeframe specified.
8. The Licencee shall remove any litter accumulated along the access road and around the perimeter of the site. Litter collection shall occur at minimum twice annually or as required by an Environment Officer.
9. The Licencee shall remove the domestic solid waste stream deposited at the Facility at minimum every thirty (30) days or at a frequency required by an Environment Officer, in order to prevent odours and attraction of vectors.
10. The Licencee shall implement control measures to prevent attraction and sustenance of rodents and scavenging vectors.
11. The Licencee shall not bury or permanently dispose of any materials at the transfer station without written authorization from the Environment Officer.

### **Hazardous Wastes**

12. The Licencee shall collect and dispose of hazardous waste in accordance with The Dangerous Goods Handling and Transportation Act and other Provincial and Federal Regulations.

### **Surface Water Management**

13. The Licencee shall construct the Facility such that all uncontaminated surface water flows to the perimeter ditch and impacted water from all material storage areas is contained within the Facility boundaries.

**Burning of Specified Waste**

14. The Licencee shall obtain a Permit to Burn as required under The Wildfires Act prior to igniting any fires at the Facility.
15. The Licencee shall only burn separated and readily combustible materials such as boughs, leaves, loose straw, paper products, cardboard, non-salvageable untreated wood, and packing materials derived from wood, and only when there is an appropriate volume of this material. Plywood, composite board or other materials constructed with glues, finishes or preservatives must not be burned.
16. The Licencee shall not burn, other than those materials specified in Clause 15 of this approval, any products or materials including but not limited to plastics, composites, rubber, manures, chemically treated fabrics, mattresses, finished furniture, or man-made synthetics.

Please be advised that this approval is contingent on the acceptance of a revised Environment Act Licence that will be issued in the near future.
