**SUBJECT: Environment Act Proposal – EAP Herd North America Inc. (File No. 5817.00)**

Manitoba Conservation and Water Stewardship, Winnipeg Regional Office of Environmental Compliance and Enforcement Branch has reviewed the above noted Environmental Act Proposal for the proposed operation of an aluminum bumpers and grill guards manufacturing plant at 2168 Springfield Road in the RM of Springfield, and has the following comments to provide:

1. The EAP does not provide a detail description of all activities and different stages involved at the manufacturing process. This information is required to assess the point sources of discharges and emissions.
2. The floor plan provided in the report is inadequate to understand different locations of the facility.
3. Storage method descriptions of various chemicals and solvents, and the precautionary measures are not described in the report.
4. The EAP notes that saws and plasma cutters will be used which will result in shaving and dust. Are there any dust collectors installed? Is there an exhaust from the plasma cutter that emits to the environment?
5. The proposal indicates that smoke will be generated, collected and filtered from the air in welding areas. How many separate welding areas are in the facility? What type of abatement equipment is installed in those areas? What is the maintenance frequency of such equipment?
6. The proposal states that painting will occur on site. Is there a paint booth on site? If so what filters are used in the paint booth?
7. Are there any stacks on site? Do any of the machines or manufacturing activities in the facility emit directly to the environment? If so, what kind of air pollution abatement devices have been installed (i.e. Scrubbers)?
8. The proponent notes that an acid base cleaner (Weld Clean) is used in the process. Are spill kits available on site?
9. Is there an Emergency response plan for the facility?
10. Have any internal or external air quality studies been conducted at the facility? If so, what are the outcome of such studies?
