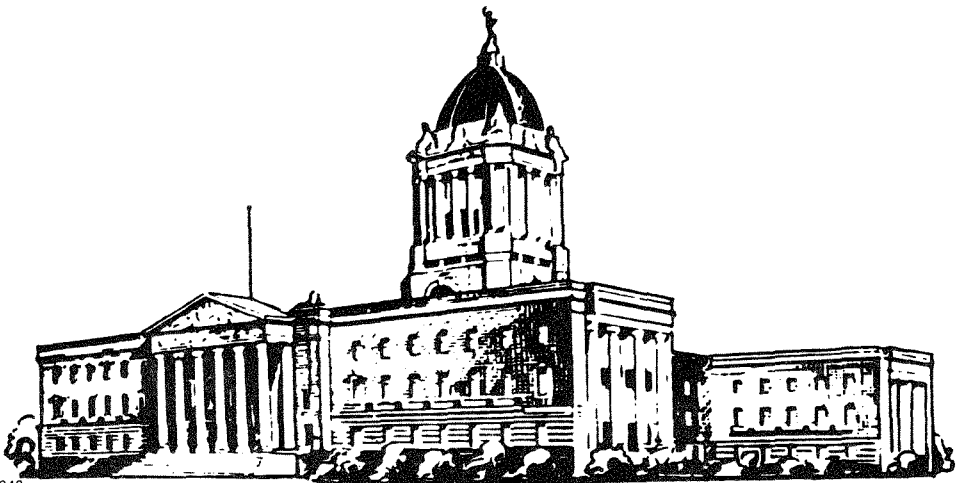

ORDERS OF THE DAY

MR. SPEAKER: The Acting Government House Leader.

HON. A. MACKLING: Bill 95, Mr. Speaker.

MR. SPEAKER: On the proposed motion of the Honourable Minister of Labour, Bill 95, the Honourable Member for Tuxedo.

MR. G. MERCIER: Mr. Speaker, we would ask that this matter stand; it is a complicated, complex subject.

MR. SPEAKER: The Honourable Minister of Natural Resources.

HON. A. MACKLING: Yes, Mr. Speaker, I'd indicated this morning that we weren't prepared to allow any bills to stand. We're in Speed-up at the request, at the instigation of the opposition, we want to move the bills.

QUESTION put, MOTION carried.

MR. G. MERCIER: Yeas and nays, Mr. Speaker.

MR. SPEAKER: Call in the members.

(And the division bells having stopped at 3:30 p.m.)

MR. SPEAKER: Order please. The time being 3:30, I have been advised, in writing, by the Official Opposition Whip that the opposition will not return before 9:30 tomorrow. In view of this advice I have informed Chamber staff that they will not be required to remain on duty outside normal working hours. I've made arrangements to secure the Chamber during this period and the sounding of the bells will be minimized to the greatest extent possible.

I am accordingly leaving the Chair to return at 9:30 a.m. tomorrow morning.

MR. SPEAKER: Order please. The question before the House is the Second Reading of the proposed motion of the Honourable Minister of Labour, Bill 95.

The Honourable Member for Virden on a point of order.

MR. H. GRAHAM: Mr. Speaker, did I hear the name Mr. Harapiak called out? I would ask that be noted.

MR. SPEAKER: For the information of the Honourable Member for Virden, and also for the House, there was a mistake made as to the name, but it has now been counted and does not affect the total of the votes cast.

Since the division has extended the time past the normal adjournment time of 5:30 yesterday afternoon, as required by our Speed-up Motion, I am of the opinion that we have now reached 5:30 and the mandatory adjournment hour for yesterday afternoon.

The House is then accordingly adjourned and will stand adjourned until 10:00 a.m., or immediately following that as soon as possible.
